# Judge Catherine Hammond's Last Docket

A few minutes ago, Judge Hammond ended her 16 year career as a Henrico Circuit Court Judge. Fittingly, her last docket was a Henrico Drug Court docket. Over ten years ago, Judges Hicks and Hammond formed the Henrico Drug Court in response to the large number of probation violators with substance abuse issues who could not get out of the "revolving door" of the criminal justice system. To say that in ten years the Henrico Drug Court has saved lives is axiomatic. The Henrico Drug Court has dramatically changed the landscape of dealing with substance abusers in this county, and has not just saved lives, but has helped hundreds of individuals rebuild their lives.

After the docket was complete, some tears were shed, pictures were taken, and Judge Hammond and I sat in her chambers for a short time of reflection on her career. This included law firm experience, public sector experience, and a full career as a jurist. When asked to compare herself now versus the judge that first took the bench 16 years ago, Judge Hammond sized herself up succinctly: "My heart was much smaller the day I started."

Anyone who practiced in her courtroom was well aware of Judge Hammond's devotion to the system of justice. We spoke about that and the importance of the court system as a trusted pillar of our society. The importance of timeliness, professionalism and order of the court were, and are, important to Judge Hammond to accomplish her goal of having the members of our community have

## Legislative Update CLE

On April 22, 2015, the HCBA - with the help of the McCammon Group, which sponsored the event, held its annual Legislative Update along with a cocktail reception at the Westwood Club. Henrico County Delegates Jimmie Massie, Peter Farrell and Dr. John O'Bannon were kind enough to highlight for the approximately 60 attendees a number of legislative issues addressed by the 2015 General Assembly session. Among those were budgetary and health care issues, as well as an extension of a DNA

respect for the process. "I want people who come to court to think of the system as reliable. I want people to know that they deserve to be heard and to believe that the court system works."

As many have heard Judge Hammond say before, principles of professionalism and cordiality amongst the Bar have over the years helped to reinforce her belief that the citizenry deserve a court system based upon respect. We talked about some of the most memorable cases over which she presided in her career. To follow that up, I asked what she was most proud of about her tenure as a judge. Her answer, not surprisingly, was the relationships that she had established with the members of the bar, and the mutual respect that she felt with the bar membership.

Perhaps most telling of Judge Hammond's legacy as a judge was the courtroom full of courthouse personnel who all wanted pictures and wanted to say their goodbyes. Judge Hammond commented to me that she believed it to be the courthouse workers - the deputies, clerks, probation staff, law clerks and secretaries, all integral parts of the system - that she would miss the most. With that said, a deputy assisted her with removing the last personal items from her office and she left the courthouse, beginning the next phase of her life.
