Harris, Jr., attended this two-part program, which addressed issues of interest to all three of the primary practice areas of our membership: civil, criminal and juvenile & domestic relations.

The first presentation was a panel discussion moderated by Marissa Mitchell, Immediate Past-President, and included Judge Richard S. Wallerstein, Jr. of the Circuit Court, Judge G. Barton Chucker of the General District Court, and Judges Randall G. Johnson, Jr. and Rondelle D. Herman of the Juvenile and Domestic Relations Court. Remembering Judge John A. Garrett

Each year, the Bar Association takes time to remember the late Honorable John A. Garrett, a judge of the Henrico County General District Court, who we lost in December of 2004. Our members should look to the memory of Judge Garrett as an example for their own practice. His career was a model of how to conduct oneself with professionalism and compassion in the practice of law. Judge Garrett attended Virginia Military Institute, where he played rugby and earned a Bachelor of Arts in Economics. He graduated from VMI in 1978 and went on to earn his juris doctor from the T.C. Williams School of Law at the University of Richmond in 1981. Perhaps even more impressive, during this time he also served as a lieutenant in the United States Army Reserve up through to his honorable discharge in 1996.

Judge Garrett served as Commonwealth's Attorney to Louisa County before coming to Henrico as a Deputy Commonwealth Attorney in 1994. He served in that position until he was appointed to the bench in 2002. On the bench, Judge Garrett had a reputation for patience, fairness and respect for all those who appeared before him. Despite being diagnosed with a serious illness, he bravely continued to serve the citizens of Henrico until his passing in 2004. Each year, our Bar Association sponsors a charity golf tournament for our members in Judge Garrett's memory. All proceeds go to the Comfort Zone Camp, a charity selected by Judge Garrett's wife Lynn. It is an organization that provided support to the Garrett children during such a difficult time. This year, the golf tournament will be held on May 29, 2014 at The Crossings Golf Club. We hope that

NOTICE FROM YVONNE SMITH, CLERK, HENRICO CIRCUIT COURT

Effective January 1, 2014, the Henrico Circuit Court Clerk's Office began to maintain its criminal and civil cases in digital format, rather than paper. All cases will continue to be filed in paper format and will then be digitized.

We will be offering yearly subscriptions for attorneys to the Officer of the Court Remote Access (OCRA) system. This system will offer remote access to the electronic criminal and civil case files via a secure connection to the Case Imaging System. The subscription will be limited to members in good standing of the Virginia State Bar and their staff members.

Once the OCRA system is available, there will be more information and a notice about cost and a link on the home page of our website to the application/subscription form.
