Save the Henrico Court Docent Program

The Henrico County Bar Association has completed another year of assisting with the Court Docent Program, hoping it won't be the last. The program began in 1981 when the Richmond Lawyers' Auxiliary, a group of spouses of local attorneys and judges, mobilized with the common goal of familiarizing students with the Virginia court system and the honor and dignity of the legal profession. However, the docents no longer have enough members to continue to organize the program. For many years, the Henrico Bar has provided attorney volunteers to assist in the program. The Henrico County Bar Association plans to undertake the responsibility of organizing the program in the future and seeks new attorney volunteers to assist with the visits.

In the past, the docents have worked closely with the middle schools of Henrico County to plan visits to the Courts Complex for 8th graders. During these visits, the students learn an overview of the Judicial process, observe the roles of various Court officers, and usually have the opportunity to witness a proceeding. The visit also introduces students to possible career opportunities in the legal justice system. Additionally, some of the judges set aside time to speak to the students about the Virginia court system and provide guidance in the merits of adopting law-abiding lifestyles.

During these visits, attorney volunteers of the Henrico County Bar Association serve as guides through the Circuit Court,

Bench-Bar CLE

The Henrico County Bar Association held its annual Bench-Bar Conference on Wednesday, February 11, 2015, in the Board of Supervisors' Board Room at the Henrico Government Center. Approximately 100 of our members, as well as Judges Gary A. Hicks, L. Neil Steverson and L. A. Harris, Jr. attended the two-part program.

Chief Magistrate Yvette A. Via and Magistrate Robert C. Blosser led off with a presentation about the Henrico Magistrate's Office. They

General District Court and Juvenile and Domestic Relations District Court. The visits typically begin in the morning at the Juvenile and Domestic Relations District Court, where one of the judges speaks to the students about the jurisdiction of the court and how trials are conducted. Then the students take a tour of the Juvenile Detention Center. While the students visit the Detention Center, the attorney volunteer finds a proceeding in Circuit Court or General District Court for the students to observe. After the tour of the Detention Center, the students observe a hearing in in General District or Circuit Court and hear from one of the judges. Then the students have lunch and finish the visit with a tour of the jail.

Having an attorney volunteer is essential for guiding the students through the courthouses and ensuring the visits run smoothly. The attorney also keeps the children engaged by questioning the students about their observations and providing an opportunity for them to voice their own aspirations and experiences. We invite attorneys of the Henrico County Bar Association to serve as attorney volunteers for the program. Only with your help can we keep the program going for years to come. During late summer we will also launch the statesponsored "imaging program" which entails digitizing most court paperwork used. While the office workload will undoubtedly grow during this transition, the end product is truly a revolution in the way we do business. Judge and court staff will have instantaneous access to any and all documents needed in courtroom proceedings. The ultimate beneficiary is the public. Courtrooms will be able to draw upon a wide spectrum of information-past and present, from within the court system and without, when considering cases.

I am fortunate to now hold one of the most responsible and rewarding positions I have ever held. I fully recognize the attorney-clerk bond makes the court system work, and I will do everything in my power to make it operate smoothly. Please help me in this endeavor.
