From the Desk of Michael Y. Feinmel, HCBA President

On May 24, 2016, the HCBA will be sponsoring the John Garrett Memorial Golf Tournament. Carl Schwertz has written a column for this month's newsletter detailing the excitement that we hope to create with this year's tournament, in recognition that this is the 10th year that we have sponsored the tournament. A few months ago, a younger member of my office pointed to the portrait of Judge Garrett (who will always be John to those of us who knew him well) and asked who he was. I'm asking that this newsletter reprint what we wrote in 2014 about John, which is printed below.



As is often the case when you lose someone special, you read comments or you see a portrait, and you realize how little words and pictures do to represent the quality of the individual. I met John for the first time in 2000 when I interviewed with the Henrico Commonwealth Attorney's Office. I was only several months removed from the Richmond Public Defender's Office, where I had spent the majority of the first part of my career. I was just getting started in private practice, and a friend of mine had suggested that I interview with Henrico County. I was told that the office had a number of experienced attorneys who enjoyed mentoring young lawyers and that I would find the office to be a comfortable fit. In my initial interview, I remember John coming across the room, laughing, and "high fiving" me based on my response to one of the room's questions. Needless to say, I was hooked at that point. Being in a place that valued working together, teamwork, and being a part of something bigger meant so much to me, and John epitomized the Office for me. When I began working with John, I learned very quickly that no one had a more vast array of friends than John: from politicians to Hooters waitresses, everyone knew John.

John's time on the bench was well deserved, and cut far too short. Obviously, when you think back on the people who were important to you in your life, you have certain memories which are extremely vivid. I remember John, in the worst stage of his illness, sitting in a car at the soccer fields, still insisting that he would watch his son play, even though he could no longer bear the elements. But I most remember the dignity and respect that John brought to the bench. No one would confuse John with a "soft" judge, but every single person who appeared before him, be they attorney, litigant, or criminal defendant, was treated with the utmost respect. As a judge, John epitomized class - he did nothing to abuse, embarrass, or treat anyone with less than dignity. I am proud to say that trait remains with the Henrico Bench today. Each of our judges worked alongside or have memories of practicing with or before John, and, although short, his tenure as a jurist certainly impacted the manner in which our current Judges conduct court. I am certainly a better person for having known John, and to this day, I remember him fondly. Please make an effort on May 24 to come out and honor John.

Remembering Judge John A. Garrett

Honorable John A. Garrett, a judge of the Henrico County General District Court, who we lost in December of 2004. Our members should look to the memory of Judge Garrett as an example for their own practice. His career was a model of how to conduct oneself with professionalism and compassion in the practice of law.

Judge Garrett attended Virginia Military Institute, where he played rugby and earned a Bachelor of Arts in Economics. He graduated from VMI in 1978 and went on to earn his juris doctor from the T.C. Williams School of Law at the University of Richmond in 1981. Perhaps even more impressive, during this time he also served as a lieutenant in the United States Army Reserve up through to his honorable discharge in 1996.

Judge Garrett served as Commonwealth's Attorney to Louisa County before coming to Henrico as a Deputy Commonwealth Attorney in 1994. He served in that position until he was appointed to the bench in 2002. On the bench, Judge Garrett had a reputation for patience, fairness and respect for all those who appeared before him. Despite being diagnosed with a serious illness, he bravely continued to serve the citizens of Henrico until his passing in 2004.

Each year, our Bar Association sponsors a charity golf tournament for our members in Judge Garrett's memory. All proceeds go to the Comfort Zone Camp, a charity selected by Judge Garrett's wife Lynn. It is an organization that provided support to the Garrett children during such a difficult time. We hope that you will join us for a wonderful remembrance of Judge Garrett and support this worthy cause.

Bench-Bar CLE

On Thursday, January 28, 2016, the Henrico County Bar Association held its annual Bench-Bar Conference, "The Art of Persuasion: Dos and Don'ts from Those Who've Seen It All," in the Henrico County Board of Supervisors' Board Room. This year's program was a panel consisting of a judge from each of the three Henrico County courts and an attorney who practices regularly in each of those courts. The attorneys and judges provided advice for persuasive practice in each of the three courts. Linda Hobgood, Director of the Speech Center at the University of Richmond, moderated the panel discussion.

The Hon. Denis F. Soden and Nicole Fox McCabe provided practice tips for trials in Juvenile and Domestic Relations District Court. Judge Soden and Ms. McCabe explained it is more persuasive to suggest a plan of action that acknowledges and resolves a weakness in your case, rather than arguing the Guardian ad litem's bias or submitting the issue to the judge. Ms. McCabe advised attendees that a Guardian ad litem's recommendation is subject to change based on the evidence presented at trial. Judge Soden reminded attorneys of the importance of being selective with their objections and explained that he takes into consideration the letters written by juveniles in his court.

The Hon. B. Craig Dunkum and Carl R. Schwertz gave the audience helpful advice for persuasion in General District Court. Judge Dunkum remarked that his view from behind the bench has been different than he expected. As a judge, he wants to know what an attorney really thinks about his or her case and that if the attorney is direct about his or her

He reminded attorneys that the most important aspect of a hearing is the credibility of the attorney and his or her witnesses. Mr. Schwertz advised the audience it is much more persuasive to offer the judge a benefit to siding with your client rather than focusing on how losing would be a detriment to your client.

The Hon. John Marshall and M. Scott Bucci advised the audience on persuasion in Circuit Court. Judge Marshall explained the importance of addressing the unhelpful aspects of a case law that you cite in your arguments. Mr. Bucci reminded attorneys of the importance of pretrial motions and briefs even in the instance the court rules against you because it gives you another opportunity to educate the judge on an issue important to the final outcome. Mr. Bucci also pointed out that discussing the weaknesses of your case gives you the opportunity to couch them and helps you gain credibility with the judge and jury. All of the judges remarked on the importance of using objections selectively in trials with pro se parties and advised attorneys to keep in mind that many of these parties just want the opportunity to be heard.
