- The judges shared that deputies will be handing out surveys to assist the judges in court improvement efforts.
- Informational materials were provided for two new services: 1) There is a new crisis stabilization unit at St. Joseph's Villa. The resource is available for youth ages five to 17 experiencing behavioral health crises in need of short-term, out-of-home placement or stabilization in their home environment. 2) Commonwealth Catholic Charities is now offering a supervised visitation program at their Richmond office. The fees for this service will be assessed on a sliding scale.

The HCBA thanks the judges and all those attending for supporting this wonderful event. We also wish Judge Soden a speedy recovery from his recent surgery and look forward to his return to the bench.

Implicit Bias Ethics CLE
