### **Ethics CLE**

On Wednesday, October 26, 2016, the Association held a CLE on "Cyber Security and Wire Fraud". The panel consisted of Tom Auth from Minnesota Lawyers Mutual, Paul Georgiadis of Paul D. Georgiadis, PLC, Barry Montgomery with Kalbaugh, Pfund & Messersmith, and Marshall Ross with Goodman Allen Donnelly PLLC, and was moderated by Tim Gephart from Minnesota Lawyers Mutual. The two-hour presentation gave insight into exactly how hackers can infiltrate emails and computer systems to commit wire fraud and identity theft. Our personal and professional lives are increasingly digital - more information is created daily than has been created from the beginning of time to 2003 - and the practice of law is no exception. While cyber-crime is increasing, protecting yourself from a hacker is a skill that is unfamiliar to most attorneys.

The panel what the Bar requires attorneys and law firms to do with respect to protecting electronic communications and files. The panel also discussed how hackers infiltrate our systems, and offered attendees some valuable advice about what to do to protect their practice. Tips included how to best protect your information, how to train your staff and what to do in the event that you or your firm is hacked and information is compromised.

# Supreme Court of Virginia Announcement

The Supreme Court of Virginia is pleased to announce that a new website is available to aid self-represented litigants in the Commonwealth. The Virginia Judicial System Court Self-Help Website,

http://selfhelp.vacourts.gov/, provides neutral legal information as a public service in topical areas commonly sought by self-represented litigants, such as traffic tickets, divorce, and landlord and tenant issues.

### **VSB Council for Henrico**

The Virginia State Bar Council met on October 8, 2016, in Roanoke to discuss important issues facing the Bar. One of those issues was mandatory reporting of pro bono hours and donations. Proponents argued that such a requirement would serve as a 'call to action for all attorneys' to close the gap in access to justice for lessprivileged citizens by encouraging more Virginia lawyers to contribute time and money to legal aid entities. Opponents of the action felt that such a requirement was tantamount to "shaming" lawyers because they were not doing enough to help the indigent and the organizations who serve them.

# Breakfast with the Juvenile & Domestic Relations District Court Judges

On September 28, 2016, the Association hosted its annual Breakfast with the Juvenile and Domestic Relations District Court Judges. Attorneys mingled in the informal setting, while enjoying bagels, donuts and coffee.

The Hon. Stuart L. Williams, Jr., The Hon. Rondelle D. Herman and The Hon. Randall G. Johnson, Jr. were in attendance. Judge Williams and Judge Johnson addressed the attorneys who were present. Judge Williams noted some upcoming changes in staffing, including the hiring of a new judicial assistant and deputy clerk. He also reported that the Court will be going paperless in the coming months.

Judge Johnson advised that the Court has put in an application for a Juvenile Drug Court program. A meeting was scheduled for mid-October and a decision will be made shortly thereafter. The Judges will be making decisions regarding attorney guardians ad litem once the Juvenile Drug Court is approved. Judge Johnson thanked applicants for their interest.

Collaborative Professionals of Richmond sponsored the Breakfast. Mollie Barton and Susan Buniva gave an overview of the collaborative process from legal and mental health perspectives. The Association thanks Collaborative Professionals of Richmond for their sponsorship!

Debate on the topic was spirited and lasted more than two hours. The final vote was 29-25 in opposition to the requirement. Nevertheless, the Virginia Access to Justice Commission will submit its proposal to mandate pro bono reporting to Supreme Court of Virginia shortly.
